3. COSHH – Chemical Exposure

Use of cleaning chemicals (including ovens and canopies)	Cleaners, others	Burns, irritation, respiratory issues	 Use only approved products Use as directed and dilute correctly Use in well-ventilated rooms only Harsher chemicals used only on

4. Stairs – Cleaning & Vacuuming

Hazard	Who Might Be Harmed	Risk	Control Measures
Cleaning staircases, leaning over edges	Cleaners	Slips, falls	 Use safe posture Cords tucked securely; avoid tugging Vacuum placed securely on level above or below Only carry mop buckets upstairs if essential; use caution and fill minimally Cleaners must not lean over balconies or banisters

5. Electrical Safety

Use of vacuums and machines	Cleaners	Electric shock or fire	Visual checks before useCustomer equipment is their responsibilityPAT testing on Simply Dazzle equipment

6. Fire Risk

Flammable substances, faulty electrics	Cleaners, public	Fire or injury	 Cleaners must review fire procedure at each site Identify and read extinguisher instructions Use extinguisher only to aid personal evacuation Customers are responsible for

7. Lone Working

Working alone	Cleaners	Delayed response, security risk	 Clock-in/out system Emergency contact protocol No ladders or standing on chairs when alone Identify escape route or lockable safe room Do not lean over balconies or banisters

8. Carpet Cleaning Machines

Hazard	Who Might Be Harmed	Risk	Control Measures
Using Rug Doctor / Karcher-style machines	Cleaners	Shock, trip, injury	 Check wiring and casing for damage before use Do not use damaged machines; report to management Follow manufacturer instructions and watch Rug Doctor training videos

9. Lighting Conditions

Hazard	Who Might Be Harmed	Risk	Control Measures
Poor lighting	Cleaners	Trips or hazards missed	Clean only in adequate lightingReport poor lighting to client/managementMake dynamic assessment to determine if work is safe to proceed



10. First Aid Procedures

Hazard	Who Might Be Harmed	Risk	Control Measures
Injuries on site	Cleaners	Lack of response, infection	 Cleaners to locate and familiarise with on-site provisions Use personal kits if needed Record in site accident book and notify management Report any use of personal kit for replenishment Cleaners must ensure kits are in-date or report if not

11. Cross-Contamination & Hygiene

Hazard	Who Might Be Harmed	Risk	Control Measures
Infection or chemical transfer	Cleaners, others	Illness or exposure	 Cloths and mops washed at 60°C+ after use Colour coding used where required Disposable gloves used for all tasks

12. PPE – Personal Protective Equipment

Hazard	Who Might Be Harmed	Risk	Control Measures
Inadequate PPE	Cleaners	Injury or exposure	 Gloves provided Footwear must be closed-toe, non-slip, and appropriate Cleaners must check PPE condition and availability regularly



13. Dynamic Risk Assessment on Site

Hazard	Who Might Be Harmed	Risk	Control Measures
Changing site- specific hazards	Cleaners	Missed safety concerns	 Dynamic assessment done by cleaner and manager at each site Review lighting, fire exits, stair use, escape routes, lone worker risks, equipment conditions
